By signing this form, which indicates that your child will participate in the listed activity, you will be waiving and releasing any and all claims for injuries that your child might sustain as a result of his/her participation in the Activity.**

I hereby represent that my child is in good physical condition and does not suffer from, and is not under the care of a physician for, any condition that would prevent or limit his/her participation in the Activity’s activities. I further represent and warrant that my child has adequate medical, health, and/or other insurance coverage for participation in the Activity. I fully understand that my child may be injured as a result of his/her voluntary participation in the physical activities offered in the Activity. Further, I acknowledge that by participating in the Activity, I, on behalf of my minor child, assume full responsibility for and risks associated with participation in any of its physical activities, including, but not limited to injury, allergic reaction, illness, damage to person or property, loss, and/or death.

In consideration of allowing my child to participate in the Activity, I, on behalf of myself, my child, and my heirs, executors, agents, and assigns, hereby waive, relinquish, release, covenant not to sue, and agree to hold harmless the District, its Board members, officers, administrators, employees, agents, representatives, volunteers, insurers, assigns and successors, from and against any and all claims, charges, demands, suits, causes of actions, losses, liability, damages whether known or unknown, past, present, or future, including, but not limited to, any and all costs, expenses, and attorneys’ fees, by reason of any injury, allergic reaction, illness, damage to person or personal property, loss, death, or other harm suffered by my child arising out of, in connection with, or in any manner related to his/her participation in the Activity, whether caused by the negligence, mistake, or other action or inaction of the District or otherwise. I further waive, on my behalf and on behalf of my child, any right of subrogation which might otherwise exist in or accrue to me or my child on account of my child’s participation in the Activity.

**I have carefully read this Release and Waiver of Liability and Indemnity Agreement and fully understand its contents. I am aware that, by signing this document, I am waiving my right and the right of my child, to the extent allowed by law, to sue the District and its Board members, officers, administrators, employees, agents, representatives, volunteers, insurers, assigns and successors.
